## Additional information

### California Proposition 65

Proposition 65, the Safe Drinking Water and Toxic Enforcement Act of 1986, was enacted as a ballot initiative in November 1986. The Proposition was intended by its authors to protect California citizens and the State's drinking water sources from chemicals known to cause cancer, birth defects or other reproductive harm, and to inform citizens about exposures to such chemicals.

An official list of substances covered by Proposition 65 is maintained and made publicly available. This list, which must be updated at least once a year, has grown to include approximately 1.000 chemicals since it was first published in 1987. Chemicals are added to or removed from the official list based on current scientific information. All substances listed show their known risk factors, a unique CAS chemical classification number, the date they were listed, and, if so, whether they have been delisted.

California's Proposition 65 is intended to inform the public about the presence of toxic substances that cause cancer, birth defects or other reproductive harm in consumer products, which of course includes tools and tool drives. Therefore manufacturers and retailers who sell in California, unless they are not exempted, have to provide a clear and reasonable warning according to the regulation, if their products contain or release at least one of the listed substances. Nevertheless, a warning according to Proposition 65 does not mean that a product injures safety standards or regulations.

We closely follow the publication as well as the updates of this list. Whenever a substance on the Proposition 65 list is present in relevant concentrations in any of our products, we recommend the inclusion of an appropriate safe harbor warning when the tools are intended for consumer use. The associated warnings are located with the product and/or packaging.

Please note that the information reflects our current knowledge and is based in whole or in part on information provided to us by our suppliers.

#### General remark:

Some substances listed in California Proposition 65 are ubiquitous and present almost everywhere in the environment. In addition, we sometimes use natural and engineered materials.

Even though regulated substances are not intentionally used in our products, trace amounts cannot be completely excluded.
